Please refer Govt. of India Ministry of Defence, Department of Ex-Servicemen Welfare Notification No. 14(2)/2014/D (P/P)(Part-I) dated 03.03.2017 circulated vide this office Circular No. 197 dated 10.01.2018 under which direction was issued that consequent upon introduction of Aadhaar Act-2016, an individual eligible to receive pensionary benefits is required to furnish proof of possession of Aadhaar number or undergo Aadhaar authentication.

G.S.R. 160(E).—In pursuance of the provisions of section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (18 of 2016) read with section 21 of the General Clauses Act, 1897 (10 of 1897), the Central Government hereby rescinds the notification of the Government of India in the Ministry of Defence (Department of Ex-Servicemen Welfare) issued *vide* number G.S.R. 747(E), dated the 3<sup>rd</sup> March, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section(i), dated the 6<sup>th</sup> March, 2017, except as respects things done or omitted to be done before such rescission.
